# NEDCO REWARDS 2016

## Rules & Regulations

### HOW TO COLLECT REWARDS DOLLARS:

1. Purchase stocked products online and in-store from participating monthly manufacturers of the rewards program. Earn 2% or 4% in Rewards Dollars on purchases from participating monthly manufacturers. Certain restrictions may be applicable to contract programs.
2. Purchase stocked products online at [ontario.nedco.ca](http://ontario.nedco.ca). Earn 2% bonus on all online stock purchases up to a maximum of \$15,000 in qualified purchases. This equals an extra 300 Rewards Dollars per month. Projects and special orders do not apply.

### RULES AND REGULATIONS:

- A customer must register in the rewards program each year in order to be eligible for Rewards Dollars redemption. Registration forms are available online at [ontario.nedco.ca](http://ontario.nedco.ca) and at all Nedco branch sales counters. Send in completed registration forms by emailing to [marketing.ontario@nedco.ca](mailto:marketing.ontario@nedco.ca) or by faxing to Nedco Marketing at 905-568-1948.
- Registration is effective from the start of the month in which you register. Example: If you sign up April 15th, you will accumulate Rewards Dollars for purchases from April 1st to the end of the program - December 31st. If you sign up September 30th, you will accumulate Rewards Dollars for purchases from September 1st to the end of the program - December 31st.
- To register in the program you must have a valid email address, as well as log-in access to [ontario.nedco.ca](http://ontario.nedco.ca). (You can register for log-in access at [ontario.nedco.ca](http://ontario.nedco.ca) by clicking on "register" at the top of the screen.)
- Customers who register in the Nedco Rewards 2016 agree that by completing the registration form & submitting it to Nedco, that they are registering with the full knowledge of their company and that they are the authorized person to do so on behalf of their company. A company can only have one contact for the rewards program.
- Nedco Rewards 2016 promotional period is in effect from April 1st to December 31st, 2016. The program results are calculated on the volume of online purchases calculated as Rewards Dollars (to a maximum of \$15,000 in qualified purchases per month) plus Rewards Dollars on participating monthly manufacturer products earned in a month.
- A summary of your 2016 total Reward Dollars earned will be emailed on a quarterly basis to your account email address. Customers with multiple accounts will receive, on a quarterly basis, a summary of their 2016 total Reward Dollars earned via their main account email address provided on the form.
- Nedco's computer records will be considered the official record of all purchases and dollar volumes for 2016.
- Customers may only redeem rewards that does not exceed their total number of Rewards Dollars earned in the program. Rewards Dollars are redeemable for a gift card after the program period has ended and must be ordered within a month from email notification.
- Customers must redeem Rewards Dollars for gift cards offered solely by Nedco. Rewards Dollars may not be redeemed for payment against a customer's Nedco account. No other forms of cash payments will be made to customers. Gift cards cannot be refunded or exchanged.
- A minimum of 25 Rewards Dollars is required to redeem for any gift cards. If you have less than 25 Rewards Dollars, you will not be eligible for a gift card redemption.
- Any Nedco account with an outstanding balance that exceeds 60 days, will not qualify and gift card redemption will not be an option.
- Nedco is the sole judge of eligibility. Nedco reserves the right to substitute a reward of similar nature or value subject to availability at the end of the program.
- Rewards customers are fully responsible for any tax implications regarding all rewards received from the program.
